2026–2027 Announcements

New PSFA 2026 Essentials (EL26) Series

The Pennsylvania State Fire Academy's new 2026 Essentials curriculum includes three levels of training:

- **EL26 Fireground Support (ELFS)**
- **EL26 Firefighter I Training (ELFF1)**
- **EL26 Firefighter II Training (ELFF2)**

Each level aligns with NFPA 1010, which replaces the previous NFPA 1001 Job Performance Requirements (JPRs). Each training level also has an associated Pro Board/IFSAC certification.

Transition Requirements for Current Essentials Students

Students who have completed one or more of the following EL22 courses must complete the **BEL22_26 Bridge Course** to transition to the new EL26 curriculum:

- EL22 Introduction to the Fire Service (ELIS)
- EL22 Fireground Support (ELFG)
- EL22 Exterior Firefighter (ELEF)

Available bridge-course dates are listed under the **Essentials of Firefighting** section.

New NFPA 1010 Certification Pathway

The following Pro Board/IFSAC certifications are available under NFPA 1010:

- Support Firefighter
- Firefighter I
- Firefighter II

Important certification requirements include:

- Candidates must first earn **Support Firefighter NFPA 1010 Certification** before testing for **Firefighter I NFPA 1010 Certification**.
- PSFA-approved Structural Burn Sessions (SBS) are no longer accepted as a stand-alone pathway unless submitted with a Bucks Basic Fire Academy program.
- Individuals who completed an Essentials series before EL14 or EL22 are not eligible to test under the new certification pathway and must complete the entire current series. This requirement applies only to certification eligibility.
- Candidates seeking **Firefighter II NFPA 1010 Certification** must complete either **EL26 Firefighter II Training (ELFF2)** or the former **EL22 Advanced Firefighter** course. Candidates may no longer challenge the Firefighter II certification without completing the required training.

Act 155: Interior Firefighter Training for 17-Year-Olds

Based on changes to the new Essentials curriculum, the PSTC will permit qualified 17-year-old students to complete **Level II—EL26 Firefighter I Training (ELFF1)**, subject to all applicable Act 155 requirements.

Beginning in 2027, the PSFA will require candidates to complete a specialized preparation course before testing for the following Driver/Operator certifications:

National Fallen Firefighters Foundation (NFFF) Symposium at the PSTC

National Fallen Firefighters Foundation (NFFF) Symposium at the PSTC

The National Fallen Firefighters Foundation offers a variety of training for the fire service including courses on: community risk reduction, firefighter behavioral health, firefighter LODD prevention, and LODD preparedness. **Tuition / Material Fee: FREE**, Limited to 64 seats. This Symposium held on Sunday, March 14 at the PSTC from 8 a.m. to 5 p.m. with free lunch provided - will present the following three (3) programs:

1. **Leadership, Accountability, Culture, and Knowledge (LACK)** – Is your department on the path to a LODD? This compelling presentation by the National Fallen Firefighters Foundation examines the root causes of LODDs and the role leadership, accountability, culture, and knowledge play as it influences the result. Many fire departments across the United States “LACK” the right stuff to prevent them from being on a path to a line of duty death, with Leadership, Accountability, Culture, and Knowledge being the elements that need to be addressed and managed in those environments. Through education and training, those departments can improve their survivability by understanding the root causes of firefighter fatalities and tackling these four elements with special emphasis on understanding fire service culture. Presentation time: 4 hours.
2. **“Functions of Command”** – This presentation is built on Chief Alan Brunacini’s “8 Functions of Command” and includes a unique segment on how ICs can “EATT” the command elephant one bite at a time and discussion on John Boyd’s OODA Loops. Includes interactive exercises. Presentation time 2-2.5 hours.
3. **The First Five Minutes for First Due** – This two-hour presentation highlights the impact of the first arriving officer’s actions, their role in organizing incident scenes, discusses strategies for establishing a standard mental model, introduces the concepts of strategic grounding and tactical patience, and introduces OODA Loops to company officers. Presentation time: 2 hours.

Emergency Medical Services

Become an Emergency Medical Technician

Begin your path to becoming an EMT! Our Emergency Medical Technician course provides the knowledge and hands-on skills needed to deliver life-saving pre-hospital care. The curriculum follows the National EMS Education Standards. Upon successful completion of the course, you will be eligible to take the National Registry Exam (Registry exam fees not included).

Emergency Medical Technician

Course Requirements:

- Be at least 16 years old.
- Complete an FBI Fingerprinting background check (This is a Department of Health - Bureau of Emergency Medical Services requirement for all EMT students as of January 1, 2026). It must be less-than 90-days old at the time of the EMS application, which is normally completed by the student post PSTC registration and approval, but no less than 2-weeks after the class starts. PSTC is recommending a window of 60-days prior to class starting, providing a 30-day window post class for any issues with the process. Thus, about 60-days prior to the start of class, you should complete this background check. Each EMT class provides the recommended dates to start working on this clearance. Recommended dates and directions provided at PSTC EMT website. The individual applying for certification is responsible for all expenses related to the FBI background check.
- Possess the physical and mental abilities as defined by the Pennsylvania Department of Health Function Job Description.
- Complete 10 patient contact experiences; details provided the first night of class.
- Complete an American Heart Association Basic Life Support for Healthcare Providers course; this requirement is offered as a part of the course.
- Complete PA State Fire Academy (PSFA)-approved Hazardous Materials Awareness course. This requirement is not part of the course curriculum and must be obtained outside of class; it is available online for free (Explained first night of class). Currently trained individuals with a current PSFA HMA, HMO or R is acceptable; must be current by the end of the class.
- Obtain certification for ICS 100 , IS 200, NIMS 700, & Traffic Incident Management (TIM). These programs are not part of the course curriculum and must be obtained outside of class; they are available online for free (Explained first night of class).
- Register with the Department of Health EMS Application System.
- Directions for obtaining FBI fingerprinting, HMA and other online programs, to include Department of Health registration available at PSTC EMT website.
- Complete Schedule(s) available PSTC EMT website.

PSTC Registration, Training, and Facility Policies Important Information for Students and Fire Departments

REGISTRATION REQUIREMENTS

- **PRE-REGISTRATION** is required to ensure sufficient enrollment.

Student Eligibility and Participation Requirements

- Students must meet the minimum age established by the Pennsylvania State Fire Academy (PSFA) no later than the first day of the program. Proof of age may be required and must be provided upon request.
- Students with facial hair that interferes with the required facepiece seal will not be permitted to participate in programs requiring the use of self-contained breathing apparatus, in accordance with PSFA standards.
- Students are responsible for providing all required classroom materials, work clothing, personal protective equipment, self-contained breathing apparatus, and other safety equipment identified for the program.
- Students must provide proof that all prerequisite training has been completed. A copy of each required prerequisite certificate must be submitted on the first night of class for admission to the program.
- Students should arrive at least 15 minutes before the scheduled start time and bring a pen and paper.

Registration, Enrollment, and Course Cancellation

- Course-specific information will be sent to the email address provided during registration.
- Unless otherwise stated, each course requires a minimum of 10 students and permits a maximum of 30 students.
- Courses that do not meet minimum enrollment at least five days before the start date will be canceled.
- If a course is canceled, registered students will be notified by email and all paid tuition will be refunded.

Refund and No-Cancellation-Fee Policy

This policy applies to courses conducted at the PSTC and courses hosted by fire departments.

- A registration must be canceled at least three calendar days before the first class session to avoid being charged tuition and material fees.
- A student who does not cancel by the deadline will be responsible for all applicable charges and may not register for or attend additional courses until the outstanding balance is paid.
- A student who withdraws after a course begins will be charged prorated tuition based on the number of class days attended. Material fees are nonrefundable and will not be prorated.
- A student who fails a course will be responsible for the full tuition and all applicable fees.
- Students with an unpaid balance resulting from withdrawal, failure, or late cancellation may not attend additional courses until payment is made.
- EMT students should consult the EMT Student Handbook for the applicable EMT refund policy.

Certificates of Completion

- Certificates of completion will be issued electronically to the email address provided by the student. Depending on the time of year and processing volume, delivery may take up to 45 days.

Westmoreland County Fire Departments

- Subject to facility and staff availability, Westmoreland County fire departments may schedule a three- to eight-hour special training session at the PSTC at no charge.
- A completed Facility Usage Form is required. The form is available on the PSTC website under the Facilities section.
- Because of NFPA 1403 requirements, fire departments may not independently conduct live-fire training in the PSTC Class A burn building.
- Private department burns remain available and are encouraged; however, they must be conducted with PSTC staff.
- Fire department-hosted training is now offered on a pay-as-you-go or tuition-based basis rather than through training packages. Contact the PSTC Director for current pricing.
- Due to increased operating costs, fire departments will be charged the actual operating cost of a fire department burn day or structural burn session.
- Facility rental may be available to outside Educational Training Agencies and independent training organizations, subject to PSTC requirements and approval. Contact the PSTC Director for pricing and eligibility requirements.

Out-of-County Fire Departments

- PSTC facility rental is available to out-of-county fire departments. Contact the PSTC for current pricing, availability, and facility-use requirements.

Acquired-Structure Burns

- The PSTC may facilitate acquired-structure burns. The property owner or host fire department is responsible for ensuring that all Pennsylvania Department of Environmental Protection (DEP) and PSFA documentation requirements are satisfied. Contact the PSTC for pricing, scheduling, and additional requirements.

EMS Continuing Education Credits

- Westmoreland PSTC no longer directly issues EMS continuing education credits. Certificates from approved PSFA courses that qualify for continuing education may be submitted to EMS West through the endorsement process. Contact EMS West for assistance with submitting eligible certificates of completion.
